**All Hands-on Deck: Managing Experts Before Trial**

This session will chart a practical, defense-focused course through expert discovery—helping attendees navigate when to bring experts aboard, how to keep them on course with pretrial obligations, and how to integrate their opinions into a trial strategy that stays seaworthy from port to verdict.
